Dear Ms. Crow:

This is in further response to your FOIA request. We have collected documents and records from several offices within CBP and release those records with redactions as described below. We are continuing the searches and will provide any additional responsive information to you on a rolling basis.

Thus far, the FOIA Appeals Policy and Litigation Branch (FAPL) has requested searches from several offices within CBP in which responsive records could likely be found: the Office of Border Patrol (OBP), the Office of Field Operations (OFO), the Office of Internal Affairs (IA) the Office of Training and Development (OTD), the Office of Public Affairs (OPA) and the Office of Chief Counsel (OCC).

OBP provided two records: the first being information from a manual entitled, "the Border Patrol Handbook" and the second being a legacy Immigration and Naturalization Service (INS) memorandum from 1997 entitled "Procedures for Granting of Voluntary Departure and Issuance of Form I-862". We redacted both records and have attached copies in response to your request.

OFO identified and provided the following records which CBP is releasing to you with redactions:

1. Processing a Voluntary Return 1.3.2 - Instructor Guide

2. Processing a Voluntary Return through Port of Entry 5.4.2 – Instructor Guide

3. A memorandum entitled "Guidance on Voluntary Returns Involving Contract Employees."

4. An Excel spreadsheet (converted to PDF) from OFO that indicates the number of voluntary returns effected by CBP from 2009 through 2011.

In addition, OFO identified and provided a two-paged document entitled "Pointers for Voluntary Departure Processing (Full VR screens)" which describes and instructs personnel in the function and use of, and sets forth step-by-step technical instructions for entering data into, a CBP law enforcement database. CBP is withholding this document in full under Exemption (b)(7)(E) (5 U.S.C. § (b)(7)(E). The document is being withheld in full because it provides a detailed and precise road map of how to search and navigate one of CBP's law enforcement databases. Release of this information would reveal step-by-step instructions on how to access and utilize the database. The record is protected to prevent unauthorized access to information which could result in alteration, loss, damage or destruction of data contained in the computer systems.

The Office of Internal Affairs (IA) provided an Excel spreadsheet itemizing eight hundred and twenty one (821) complaints made against CBP personnel. We are unable to discern whether any of the 821 cases has a nexus to voluntary returns. The Excel file was converted to a PDF file from which names and numbers which could identify individuals were redacted. That record is attached as well.

Given that the request sought training materials, we also requested information from the Office of Training and Development (OTD). The provision of training materials within the information disclosed by OFO notwithstanding, OTD is conducting a separate search for responsive records.

Given that the request sought directives, guidance, etc., we also requested information from the Office of Chief Counsel (OCC). We are informed OCC is conducting a search for responsive records as well.

We also requested information from the Office of Public Affairs (OPA). We requested records from the OPA Complaints Center. We did not receive records that are responsive to your request.

Certain information that is contained in the responsive records is exempt from disclosure pursuant to Exemptions (b)(6), (b)(7)(C) and (b)(7)(E) of the FOIA (5 U.S.C. \S 552 (b)(6), (b)(7)(C) and (b)(7)(E)) and was therefore redacted from the records disclosed. Some information has been withheld pursuant, respectively, to Exemption (b)(6), which protects from disclosure "personnel and medical files and similar files" the release of which could constitute an unwarranted invasion of personal privacy; Exemption (b)(7)(C), which protects from disclosure information compiled in a law enforcement context if its disclosure could constitute an unwarranted invasion of personal privacy; and Exemption (b)(7)(E), which protects from disclosure information compiled for law enforcement purposes, "if such disclosure could reasonably be expected to risk circumvention of the law[.]"

The FOIA requires an agency "upon any request for records which . . . reasonably describes such records . . . [to] make the records promptly available." 5 U.S.C. § 552(a)(3).

In this way, FOIA allows citizens to peek behind the curtain and find out "what their government is up to." United States Dep't of Justice v. Reporters Comm. for Freedom of the Press, 489 U.S. 749, 773, 109 S. Ct. 1468, 103 L. Ed. 2d 774 (1989) ("Reporters Comm."); Solar Sources, Inc. v. United States, 142 F.3d 1033, 1037 (7th Cir. 1998). Sutton v. IRS, 2007 U.S. Dist. LEXIS 299 (N.D. III. 2007).

The Freedom of Information Act generally provides citizens the right of access to federal agency records, except insofar as they are protected from disclosure by one of nine exemptions or three law enforcement record exclusions. "The basic purpose of [the] FOIA is to ensure an informed citizenry, vital to the functioning of a democratic society, needed to check against corruption and to hold the governors accountable to the governed." *NLRB v. Robbins Tire & Rubber Co.*, 437 U.S. 214, 242 (1978). *Public Citizen v. Department of State*, 1991 U.S. Dist. LEXIS 11962 (D.D.C. Aug. 26, 1991).

The FOIA requires that federal agencies comply with requests to make their records available to the public, unless such "information is exempted under [one of nine exemptions set forth in] clearly delineated statutory language." *Id.* (internal quotation marks omitted); see also 5 U.S.C. § 552(a), (b)(As quoted by *Bangoura v. United States Dep't of the Army*, 2009 U.S. Dist. LEXIS 29541 (D.D.C. Apr. 8, 2009)).

Congress remained sensitive, however, to the need to achieve balance between this objective and the vulnerability of "legitimate governmental and private interests [that] could be harmed by release of certain types of information." Critical Mass Energy Project v. Nuclear Regulatory Comm'n, 298 U.S. App. D.C. 8, 975 F.2d 871, 872 (D.C. Cir. 1992). As quoted by Peter S. Herrick's Customs & Int'l Trade Newsletter v. United States Customs & Border Prot., 2005 U.S. Dist. LEXIS 38915 (D.D.C. Sept. 22, 2005) ("Herrick I").

Exemption (b)(6)

FOIA Exemption (b)(6) provides for the exemption from disclosure of "personnel and medical files and similar files" disclosure of which "would constitute a clearly unwarranted invasion of personal privacy." 5 U.S.C. § 552(b)(6). The United States Supreme Court in *United States v. Washington Post Co.*, 456 U.S. 595 (1982) stated, citing the legislative history of the FOIA, that the phrase "personnel and medical and similar files" was to be broadly interpreted. Once the threshold requirement that the records are "personnel and medical and similar files" is met, the issue becomes whether disclosure of the information "would constitute a clearly unwarranted invasion of personal privacy." 5 U.S.C. § 552(b)(6). The resolution of this issue involves a balancing of the public's right to know the information against the individual's right to privacy. See, Department of Air Force v. Rose, 425 U.S. 352 (1976).

Please be advised that the names of individuals withheld pursuant to Exemption (b)(6) (and Exemption (b)(7)(C); set forth and discussed below) pertains to the names of the CBP personnel and other individuals whose names appear in the memoranda, directives and IA complaint files. In *Canaday v. United States Citizenship & Immigration Servs.*, 545 F. Supp. 2d 113, 118 (D.D.C. 2008), the United States District Court for the District of Columbia, in considering the invocation of Exemption 6 to withhold the names of federal employees, held that:

USCIS invoked Exemption 6 to protect the identities of certain Federal employees. See, *e.g.*, *Vaughn* index at 4 ("The release of these names would be a clear invasion of the personal privacy of those individuals while, at the same time, [would] serve no legitimate public interest since the release of this information would shed no additional light on the manner in which this agency fulfills its statutory obligations.")... While there may be some public interest in obtaining the identifying information of the Federal employees at issue, disclosure would not shed any light on the workings of USCIS. *Canaday, supra*, at 118.

In this case, the CBP employees' and other individuals' rights to have their names and other identifying information withheld from disclosure outweigh the public's interest in knowing this information. The privacy consideration is to protect CBP personnel, as individuals, from unnecessary, unofficial questioning and harassment as to the conduct of their duties, whether or not they are currently employed by CBP. Further, disclosing the information redacted from the document in this case, *i.e.*, names and other personal identifying information, does not shed light on how CBP performs its statutory duties. Thus, Exemption (b)(6) has been applied to withhold the names of CBP employees and other individuals.

Exemption (b)(7)(C)

In addition to the application of Exemption (b)(6), the name of CBP employees and other individuals are withheld under Exemption (b)(7)(C). Exemption (b)(7)(C) exempts from disclosure "records and information compiled for law enforcement purposes" the disclosure of which "could reasonably be expected to constitute an unwarranted invasion of personal privacy." 5 U.S.C. § 552(b)(7)(C). Exemption (b)(7) applies to civil, criminal, and administrative law enforcement proceedings, and protects, among other information, the identity of law enforcement personnel and third parties referenced in files compiled for law enforcement purposes. Exemption (b)(7)(C) is asserted to protect the identities and contact information of CBP employees responsible for creating the record in question and conducting law enforcement activities. The primary consideration is to protect CBP employees as individuals from unnecessary, unofficial questioning and harassment as to the conduct of their duties. Exemption (b)(7)(C) is also asserted to protect the identities of other third party individuals (e.g., individuals who filed complaints regarding mistreatment by CBP personnel, etc.).

The responsive records, containing the names and/or identifying information of CBP employees and other individuals, meet the requirement for being compiled for law enforcement purposes. CBP is a law enforcement agency whose mission is to protect the borders by enforcing the customs and immigration laws of the United States. Given the nature of your request and the location of the responsive records, the records disclosed are considered law enforcement mandate to monitor and protect the U.S. borders. The individual whose privacy would be subject to invasion is identified in the records, and the invasion of that privacy is unwarranted. There is no public interest to be served by placing the identities and contact information of CBP employees and other individuals before the public. Thus, we conclude that Exemption (b)(7)(C) is applicable to the information withheld from disclosure.

Exemption (b)(7)(E)

Exemption (b)(7)(E) protects from release all law enforcement information that "would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law." 5 U.S.C. §552(b)(7)(E). (See Nowak v. IRS, 2000 U.S. App. LEXIS 948 (9th Cir. 2000)(Exemption (b)(7)(E) authorizes the withholding of records and information that consist of or reveal a law enforcement "technique" or "procedure" when that technique or procedure is employed in law enforcement investigations.) Information that has a law enforcement purpose where disclosure would risk circumvention of law and agency regulations is being withheld under Exemption (b)(7)(E). Disclosure of the information in this matter would reveal OFO targeting and inspection techniques used in the processing of international travelers and would enable potential violators to design strategies to circumvent the examination procedures developed and employed by CBP. Additionally, release of the information would reveal Border Patrol law enforcement techniques used in the apprehension and processing of aliens illegally entering the United States between ports of entry and would enable potential violators to design strategies to circumvent the border security enforcement procedures developed by CBP. Lastly, the excerpts from the "pointers for processing", directives and memoranda provide detailed and precise road maps of how to search and navigate CBP's law enforcement databases. Release of this information would reveal step-by-step instructions on how to access and utilize the databases. The information contained in these records is protected to prevent unauthorized access to information which could result in alteration, loss, damage or destruction of data contained in the computer systems.

The fact that this matter is already in litigation notwithstanding, we are required by law to advise you that, in the event that you are dissatisfied with the disposition of your appeal, you may obtain judicial review of this decision pursuant to the provisions of 5 U.S.C. §552(a)(4)(B) in the United States District Court in the District in which you reside, in the District where the agency records are situated, or in the United States District Court for the District of Columbia.


FORM 1-274 (REQUEST FOR A RETURN TO MEXICO)

Form I-274, Notice and Request for Disposition will be executed on every deportable alien apprehended immediately upon establishing alienage and deportability (this will usually be after completion of the block portion of Form I-213, Record of Deportable Alien located/apprehended). The form will satisfy all required administrative warnings to the alien. The form becomes a record of the alien's desired disposition of his case.

A request for voluntary departure does not obligate the Service to comply with the request. Aliens requesting voluntary departure may be denied and required to appear at a deportation hearing. Conversely, aliens initially requesting voluntary departure may change their mind and request a deportation hearing at any time prior to departure. It is the responsibility of every officer to bring such requests to the attention of a supervisor, at which time voluntary departure will be cancelled and the alien given a deportation hearing.

Should an alien refuse to sign the form, the officer will note that the alien has read the form or that it has been read to him or her, and the alien will be processed for a deportation hearing.

Officers should make every effort to insure that aliens understand their rights and options, but should not attempt to influence the aliens' choice between a deportation hearing and voluntary departure.

Subject <u>Procedures for Granting of Voluntary Departure</u> and Issuance of Form I-862, Notice to Appear

To All Regional Directors from Office of Programs All Service Center Directors All District Directors All Officers in Charge

This memorandum provides guidance on the implementation of Section 240B of the Immigration and Nationality Act (INA) as amended by Section 304(b) of the Illegal Immigration Reform and Immigrant Responsibility Act (IIRIRA) and interim regulations under Title 8, Code of Federal Regulations, Part 240, Sub-part C.

VOLUNTARY DEPARTURE

Effective April 1, 1997, INA Section 240B(a) limited the Attorney General's authority to grant voluntary departure. Voluntary departure can now be granted only to those applicants/beneficiaries who actually request it and agree to its terms and conditions. Pursuant to INA Section 240B(d), noncompliance with the terms of voluntary departure is punishable by civil penalties including a fine, and ineligibility for additional grants of voluntary departure and certain other immigration benefits. Because of the new penalties, the Service must not unilaterally grant voluntary departure, either expressly or implicitly, to an applicant/beneficiary known to the Service as being out of lawful status.

Service Centers will only consider requests for voluntary departure in cases where:

- the applicant/beneficiary clearly and specifically requests it, and
- within that request, the applicant/beneficiary fully acknowledges and agrees to its terms and conditions, and
- the request is attached to a benefit-related application at the time that application is filed.

No subsequent requests for voluntary departure submitted in relation to the benefit related application will be considered at the Service Centers. (b)(7)(E)

If the beneficiary does not request voluntary departure in conjunction with a benefit-related application/petition, but may be eligible to receive it, any denial of the benefit-related application/petition must include specific language informing the

applicant/beneficiary that he/she may wish to request voluntary departure from the District Director of the District having jurisdiction over his/her place of residence. The required language is attached (see attachment 1 & this memorandum). Service Centers will include the statement that the request for voluntary departure must be made at the local office.

If the beneficiary requests voluntary departure according to the above criteria, in conjunction with a benefit-related application/petition, but that request for voluntary departure is denied, the denial of the benefit related application/petition must inform the beneficiary of the reasons for denial and that he/she may be subject to removal proceedings. The required language is attached (see attachment 2 of this memorandum). If the application/petition is adjudicated at a Service Center, the case must then be reviewed for possible referral to the local office for consideration of removal of the beneficiary. If a request for voluntary departure is denied, but the benefit-related application/petition is approved, a separate notice containing the specific language (see attachment 2 of this memorandum) must be created and issued to the applicant/beneficiary. (b)(7)(E)

If a request for voluntary departure is received that meets the above conditions and the beneficiary is eligible, the service office must issue a Form I-210 (rev. 4-I-97) to the beneficiary along with any notice of denial of the application/petition that may be issued. Service offices must complete the Form I-210, Notice of Action - Voluntary Departure, as notification to each applicant/beneficiary granted voluntary departure. Only the April 1, 1997 version of the Form I-210 may be used (a copy is attached for reference as attachment 4 of this memo).

Voluntary departure can only be granted for a period not to exceed 120 days in the aggregate. Each Director must specify the period of time permitted for voluntary departure at his/her discretion and may grant extensions. However, the total period allowed, including all extensions, shall not exceed 120 days.

NOTICE TO APPEAR

The Service will not issue a Notice to Appear in cases in which the application/petition is approved.

Normally, the Service would issue a Form I-862, Notice to Appear, in all instances where an applicant/beneficiary is out of status and is not eligible for or has not received voluntary departure. However, there are exceptions.

Aliens Ineligible for Removal Proceedings

One exception includes the following classes of applicant/beneficiaries who are ineligible for removal proceedings:



When denying an application filed by an applicant/beneficiary within the above categories, there is no need to prepare a Form I-862. However, the receipt or A-file containing the application must be sent to the local office having jurisdiction over the applicant/beneficiary's place of residence for review.

Aliens Who May Be Placed Into Removal Proceedings

Sampling data has indicated that if an NTA were issued in all other instances, the volume of NTAs generated by Service Centers would swamp local office dockets, having a serious negative impact upon docket management and removal priorities. Therefore, the Service has decided not to issue routinely Form I-862, Notice to Appear, as a standard part of processing denied applications end/or petitions filed by or on behalf of applicants/beneficiaries who are not maintaining status or in a period of stay authorized by the Attorney General However, the Service Centers will refer to local offices for potential issuance of an NTA, any application/petition denied due to a finding of fraud or criminal record, in which the applicant/beneficiary is not maintaining status (or in a period of stay authorized by the Attorney General), and there is no request for voluntary departure included (or that request has also been denied).

Referral of Cases to Local Offices

All cases being referred to the local office having jurisdiction over the applicant/beneficiary's place of residence will be forwarded only after the denial is completed and after any period in which to file an appeal or motion to reopen/reconsider has passed without one having been filed or, if an appeal or motion is filed within the requisite time period, after any dismissal of the appeal or denial of the motion has been completed.

If the applicant/beneficiary has not been assigned an alien registration number, an A-File will be created prior to shipping to the local office, if an A-File has already been created for the applicant/beneficiary, that A-Number and the location of the A-File must be noted on the referral memorandum (attachment 3 to this memorandum). Prior to shipping the file to the local office, the referral memorandum must be completed and fastened to the front of each file.

For cases being referred in which the alien is ineligible for the issuance of an NTA, a brief explanation, including an indication of the status of the applicant/beneficiary and a

request that the applicant/beneficiary be arrested and removed without a hearing, should be written in the narrative portion of the referral memorandum.

For cases being referred for possible issuance of an NTA, a brief explanation, including an indication of the status of the applicant/beneficiary and a request that the local office consider issuance of a Notice to Appear to the applicant/beneficiary, should be written in the narrative portion of the referral memorandum. The local office may issue a Notice to Appear in those cases it deems appropriate based on local docket management priorities and workload. To enable local docket control managers to more efficiently select cases referred by Service Centers for NTA issuance, HQIRM is developing an interface between the CLAIMS and DACS systems. Once this new process is fully implemented, additional criteria and categories may be designated.

Collection of NTA statistics

For future budget analysis and planning purposes, HQBEN will issue additional guidance on the collection of such data during designated periods of time each fiscal year. In the meantime, Service Centers are no longer required to capture statistics on beneficiaries of applications/petitions who are out of status to determine the number of aliens to whore an NTA could potentially be issued.

This memorandum has the concurrence of the Office of Field Operations.

ATTACHMENT 1

REQUIRED LANGUAGE TO BE USED WHEN NO REQUEST FOR VOLUNTARY DEPARTURE IS MADE BUT THE ALIEN APPEARS ELIGIBLE TO RECEIVE VOLUNTARY DEPARTURE

You may be eligible to receive a grant of voluntary departure from the United States. If you wish to request voluntary departure, you must take this notice and go to your LOCAL office of the Immigration and Naturalization Service to make that request.

A request for voluntary departure must be made in writing and must be accompanied by your original passport or other travel documentation sufficient to assure your lawful entry into the country to which you intend to depart. If that request is approved, you must also agree to all terms and conditions of the voluntary departure. If that request is approved and you fail to meet the terms and conditions set forth, you will become subject to a civil penalty of not less than \$1000 and not more than \$5000. Failure to meet the terms and conditions will also result in you being ineligible for any further relief from removal from the United States.

If your request for voluntary departure is denied, you may be subject to removal from the United States.

ATTACHMENT 2

REQUIRED LANGUAGE TO BE USED WHEN VOLUNTARY DEPARTURE IS BEING DENIED

THIS LANGUAGE WILL BE ADDED TO ALL DENIAL NOTICES OF THE BENEFIT-RELATED APPLICATION/PETITION.

THIS LANGUAGE WILL ALSO BE SENT TO ALL APPLICANTS/BENEFICIARIES WHEN THE REQUEST FOR VOLUNTARY DEPARTURE IS DENIED BUT THE BENEFIT-RELATED APPLICATION/PETITION IS APPROVED. IN SUCH CASES, THIS LANGUAGE WILL BE SENT ON A SEPARATE NOTICE

A request for voluntary departure was submitted in conjunction with this application/petition. That request is hereby denied. It has been determined that you are not eligible to receive voluntary departure because *******AD/UDICATOR ADDS REASONS pursuant to 8CFR 240 and/or INA240B***.

*** The following statement will only be added when the benefits related application/petition is denied: You should depart the United States immediately, if you do not depart immediately you may be placed into removal proceedings. ***

Guidance on Voluntary Returns Involving Contract Employees

The attached memorandum from David V. Aguilar, Chief, U.S. Border Patrol, provides guidance on Voluntary Returns of aliens involving Contract Employees.

Contract employees, such as the Wackenhut bus drivers, are neither Federal law enforcement officers nor are they immigration officials. Authorized officers who may permit aliens to voluntarily depart from the United States are listed under 8 C.F.R. 240.25. As a reminder, contract employees who are performing transportation services for the Border Patrol should not release any alien at a Port of Entry (POE) without the presence of a Border Patrol agent or a CBP Officer.

When transporting detainees to a POE, Border Patrol personnel will assist contract employees in making the necessary arrangements with either CBP Officers at the respective POE, or agents from the nearest Border Patrol Station to have an agent or CBP Officer be present at or near the pedestrian departure gate at the POE to permit and verify those aliens who are departing voluntarily from the United States.

A memorandum and signature roster acknowledging field distribution is due to Assistant Chief Patrol Agent (b)(6) (b)(7)(C) no later than July 11, 2008.

Guidance on Voluntary Returns involving Contract Employees

As the primary Federal law enforcement agency between the ports-of-entry, the United States Border Patrol apprehends numerous illegal entrants per day, and as a result has a requirement for guard and transportation services. Historically, Detention Enforcement Officers (DEOs) or Immigration Enforcement Agents (IEAs) performed a major role in the land transportation duties for the Border Patrol. Since IEAs no longer perform this function, the Border Patrol continues in its development of a detainee transportation program that minimizes or eliminates the requirement of frontline agents to perform guard and detainee transportation duties. This includes the use of contractor support to provide detainee transportation services.

Contract employees are neither Federal law enforcement officers nor are they immigration officials. Authorized officers who may permit aliens to voluntarily depart from the United States are listed under 8 C.F.R. 240.25. As a reminder, contract employees who are performing transportation services for the Border Patrol should not release any alien at a Port of Entry (POE) without the presence of a Border Patrol agent or a CBP Officer. When transporting detainees to a Port of Entry, Border Patrol personnel will assist contract employees in making the necessary arrangements with either CBP Officers at the respective Port of Entry or agents from the nearest Border Patrol Station to have an agent or CBP Officer be present at or near the pedestrian departure gate at the POE to permit and verify those aliens who are departing voluntarily from the United States.

Chief Patrol Agents are responsible for ensuring that all contract employees and Border Patrol agents under their supervision are aware of and comply with this memorandum. Chief Patrol Agents are also responsible for any coordination with the respective Office of Field Operations (OFO) within their area of responsibility.




